HORSE SALE CONSIGNMENT AGREEMENT

Owner warrants that he is the owner of a horse named _____, and that he can convey good title to the animal free and clear of any liens or encumbrances. Owner wishes to offer said horse for sale and to stable it at Clockwork Farms for that purpose.

Owners asking price is \$ _____ and in the event of the sale of the horse for said price, Mindy Hussey, Clockwork Farms shall receive a minimum commission of 10% of the sales price.

Clockwork Farms will take care of all paperwork and money transfer for the horse to be sold.

Owner agrees to pay all boarding charges monthly in advance in accordance with Clockwork Farms current rate sheet.

Owner understands that Clockwork Farms will advertise their horse on the Clockwork Farms website, (www.clockworkfarms.com), and Facebook site (<https://www.facebook.com/ClockworkFarms>) as well as other sites (i.e. Dreamhorse, Warmbloods for Sale) as deemed necessary. Owner agrees to pay all advertising costs.

If the horse becomes ill or Injured, the owner shall be notified at the below telephone numbers for instructions, and if Owner cannot be informed or does not answer the notice, or if the horse's health requires immediate action, Clockwork Farms is hereby instructed and authorized to use its best judgment in regards to measures to be taken for the welfare and health of the horse.

Any veterinary fees incurred shall be paid by owner of horse, and Clockwork Farms/Mindy Hussey shall have no liability to them. Owner agrees to keep all Immunizations current and to have the horse wormed and its teeth checked at least once a year. If the horse is in need of worming and/or its teeth floated, Clockwork Farms will have it arranged and the Owner will reimburse for the service.

Owner knows of no latent defects in the discipline of the horse which might endanger the life or limb of persons handling the horse.

Owner agrees to assume all responsibility and risk arising from the horse's activities, Clockwork Farms/Mindy Hussey activities, or the actions and activities of any person or
